S. R. O. 849(I)/2020.—In pursuance to the honourable Supreme Court of Pakistan's Order dated 20th March, 2018 and subsequent Order dated 10th January, 2020, passed in Human Rights Case No. 623-P of 2017, and the Notification by Federal Government, *vide* S.R.O No. 6-21/2018-DRAP/NHS,R&C, dated 29th May, 2018, and nominations received from provincial governments, the Ministry of National Health Services, Regulations and Coordination is pleased to constitute the National Price Fixation Committee for Life Saving Medical Devices, for a period of three years, with immediate effect, as under:

*Note: At present, Balochistan Healthcare Commission does not exist, however after its establishment, Health Department, Government of Balochistan will be requested for nomination and a revised notification will be issued accordingly.

2. The Secretariat of the Committee will be at Headquarter of Drug Regulatory Authority of Pakistan (DRAP), Islamabad and representative of DRAP will act as Secretary of the Committee.

3. A simple majority of the total membership shall constitute the quorum for a meeting of the Committee, and in case of equality of votes, the Chairman shall have a casting vote.

4. The Terms of Reference of the Committee shall be as under, namely:—

- (i) To fix and review the maximum prices of different categories of Life Saving Medical Devices based on average procurement prices obtained through the central procurement formula, subject to approval of the Federal Government; and
- (ii) To advise the Federal Government on matters related to prices of different categories of Life Saving Medical Devices.

5. No act or proceeding of the Committee shall be invalid on the ground merely of existence of any vacancy in or any defect in the constitution of the Committee.
