**QUALIFICATION, EXPERIENCE AND
AGE LIMITS FOR DIRECT RECRUITMENT**

4. A candidate must possess the educational qualifications and experience and must be within the age limits as mentioned against the posts concerned in the Schedule to this Notification provided that:—

- (i) A candidate must possess the educational qualifications and experience and must be within the age limits as mentioned against the post concerned in the Schedule to this Notification;
- (ii) The maximum age limit shall be relaxed in respect of the candidates specified and to the extent indicated in the Initial Appointment to Civil Posts (Relaxation of Upper Age Limit) Rules, 1993 as amended from time to time; and
- (iii) Eligibility of candidates shall be reckoned, as on the closing date fixed for submission of application in accordance with these Recruitment Rules and the Instructions issued by Federal Government and Federal Public Service Commission from time to time.

APPOINTMENT BY TRANSFER

5. Appointment by transfer shall be made by selection from amongst the persons holding appointment on a regular basis under Federal Government/G. B Govt., in the same basic pay scale in which the post to be filled exists, provided that the person concerned possesses the qualifications and experience prescribed for initial appointment to the post concerned.

PROBATION

6. Persons appointed by promotion, initial appointment or by transfer shall be on probation for a period of one year. This period may be curtailed for good and sufficient reasons to be recorded, or if considered necessary, it may be extended for a period not exceeding one year as may be specified at the time of appointment. Appointment on probation shall be subject to the provisions of Section 5 of GB Civil Servants Act, 2011.
