O. 1079(I)/2022.— In exercise of the powers conferred under section 20 of the PPRA Ordinance, 2002, the PPRA Board in its 1st meeting held on July 13, 2002 has delegated the Administrative & Financial powers equal to those available to the Principal Accounting Officer of a Ministry / Division to the Managing Director, PPRA.

S. R. O. 1081(I)/2022.—In exercise of the powers conferred under section 20 of the PPRA Ordinance, 2002, the PPRA Board in its 37th meeting held on April 01, 2019 has delegated all powers to the Managing Director regarding decision on the appointment related issues as well as of probation including confirmation, extension of probation and termination of service, relevant court matters, as the case may be, and authorized him to decide accordingly being Competent Authority and the only full time member of the PPRA Board.

S. R. O. 1082(I)/2022.—In exercise of the powers conferred under section 20 of the PPRA Ordinance, 2002, the PPRA Board in its 48th meeting held on April 01, 2021 approved and resolved that:—

- (a) “Managing Director, being the Secretary of the PPRA Board is hereby authorized as the signatory of the Authority for the compliance of all legal formalities and to execute relevant documentation thereof”.
- (b) “Managing Director, being the Secretary of the PPRA Board is hereby authorized to sign any contract on behalf of the Authority and to initiate, represent, file and / or defend any suit(s), legal proceedings, writ petitions, plaints, pleadings, applications, appeals before any court / tribunal / authority / regulatory body / quasi-judicial body and / or other institution; and to engage the counsel(s) and other expenses in this regard from the income of the Authority. He is also authorized to sign affidavits, court-affidavits, rejoinders, vakalatnamas, and to give evidence and do all other related matters by way of signatures or otherwise for and behalf of the Authority, also authorized to further nominate / appoint / authorize any official / representative of the Authority to do all the aforementioned actions for and on behalf of the Authority”.
