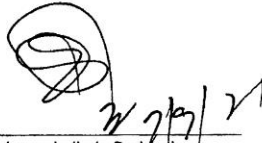
**DECISION OF THE AUTHORITY IN THE MATTER OF ADJUSTMENT IN INSURANCE

Pursuant to the indexations/adjustment mechanism stipulated in the decision of the Authority dated April 4, 2019 in the matter of tariff adjustment of Artistic Energy (Private) Limited (AEPL) at Commercial Operation Date (COD) notified in official gazette on July 17, 2019 vide S.R.O. No 814(I)/2019 and modification decision dated February 14, 2020, the revised insurance component of tariff of AEPL based on insurance cost for the period from March 16, 2021 to March 15, 2022 is indicated as under:

March 16, 2021 to March 15, 2022	71,233,632	0.4713

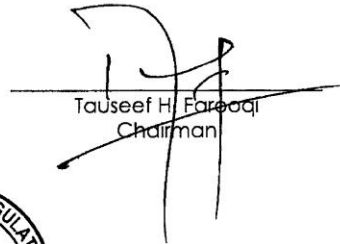

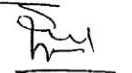
