

The present invention relates to a cooling device 100, in particular a freezer, comprising a cooling circuit 200 having a compressor 210, at least one evaporator 220, and a condenser; a space for cooling goods 300 that can be closed at its upper surface; and a coolant reservoir 400 at least partially surrounding an upper region of the space for cooling goods 300, wherein the at least one evaporator 220 is disposed in the coolant reservoir 400, and wherein the at least one evaporator 220 at least partially surrounds the upper region of the space for cooling goods 300.




