The bidding firms are required to enclose photo copy of PCP receipt regarding purchase of tender alongwith their sealed offers/bids.
2. The tender must be accompanied with Call Deposit/Pay Order/Demand Draft of Rs.500,000/- (Rupees five hundred thousand only) as earnest/security money in favor of the Manager, Printing Corporation of Pakistan Press, Islamabad. Tender receipt without security bid will not be considered and will be rejected state way.
3. The security of the successful bidder will be retained while in the case of other it will be refunded to them.
4. The offer should be valid for 90 days from the date of opening of tender.

5. The rates may be given "AS IS WHERE IS" basis for per Kg. i.e. un-serviceable machines/old machines, parts/scraps and mixed junk exclusive of Taxes, however, the successful contractor shall be liable to pay all Taxes as announced by the Government of Pakistan from time to time before lifting the material (Scrap and get separate receipt/certificate from PCP for deposit of Tax for his own record).
6. Conditional, incomplete, overwritten and ambiguous tender shall be liable to be rejected.
7. In case of default on the part of the successful bidder/contractor in carrying out the contractual obligations, the Security deposit shall be liable to forfeiture.
8. The Corporation reserves the rights to reject all or any tender in accordance with PPRA Rules 33(I).
9. The Contractor shall lift the mixed scrap and unserviceable machines as per attached list within 45 days after issuance of work order.
10. In case of failure to lift all the aforementioned material within stipulated period, the penalty @ 0.5% percent per day of the value of weighted scrap already lifted by the contractor will be imposed on the Contractor which will be deducted from the security money of the firm/party.
11. In case of any dispute in interpretation of the terms and conditions of this tender the Managing Director, PCP shall be the sole arbitrator and his/her decision shall be the final and binding upon all concerned.
